Certification, renewal opportunities and networking provide the opportunity to improve your technical expertise through the IMSA certification process. This conference will offer the opportunity to meet counterparts from other agencies to discuss common problems, solutions and operational issues you deal with in the performance of your duties.

Your Board of Directors remains sensitive to tight budgets. IMSA certification programs continue to remain a bargain, compared to other industry programs and prices are expected to remain close to 2014 levels.

All programs are expected to be offered. Our Annual Meeting is scheduled for October 28th.

Keep in mind the Traffic Signal Technician Level 1 program remains the same in scope but Traffic Signal Lev. 2 is now divided into four distinct courses of instruction.

- Michigan Temporary Traffic Control registration will be Sunday 5-7PM. (Dinner is not included)
- Certification Renewal can be accomplished at reduced cost. Exams are typically not necessary.
- > Study Guides are ordered *directly from the International* by your agency four (4) weeks in advance.
- No Study Guides will be available at the conference.
- All programs starting at 8AM *include* lodging the night *prior* to the start of the program. Should you not need lodging or food, cost will be reduced.

- Programs are offered individually. Dates and times are listed on the reservation form.
